## Application Instructions

Fill out the application form completely and then make three (3) photocopies of the front side only. All four (4) copies are to be posted on the Club Bulletin Board for inspection by the Members until the next Regular Member Meeting of the Club.

Acceptance as a Member does not insure immediate moorage space unless there is suitable space available. If suitable space is not available, Members names will be placed on a "Moorage Waiting List" in the order of the date of acceptance to membership. Exceptions may be made in the case of a small vessel and a small space available.

At least one of the Members recommending a new member applicant **MUST** be present for the membership vote. The Vice Commodore will inform applicants of the outcome of the voting procedure.

Ohio River Launch Club is a "working Club". ALL Members are expected to contribute time and effort to THEIR Club in their own way, consistent with their skills and their abilities.
