Applications for membership are posted on the Club bulletin board for inspection by the members. Applications will be considered at the next regularly scheduled monthly meeting of the full membership of the ORLC.

At least one of the members recommending a new member application **MUST** be present for the membership vote. The Vice Commodore as Membership Chair will inform applicants of the outcome of the membership vote.

Acceptance as a Member of ORLC does not guarantee immediate moorage space unless there is suitable dock space available. If suitable space is not available, members will be place on a “Moorage Waiting List” in the order of the date of the acceptance to membership.

Please note that the Ohio River Launch Club is a “working” club. ALL members are expected to contribute time and effort to the Club consistent with their skills, talents and abilities.

Moorage Membership Dues and Fees as of 2019

Moorage fees will be billed at the following rates based on the length of the vessel as measured by the Rear Commodore. These rates apply to the official ORLC boating “season” which is May 1 through November 30. Off season winter moorage is not permitted.

\$49 per foot for vessels moored on the “inside” docks

\$44 per foot for vessels moored on the “outside” dock

Social Membership – ORLC membership is available for people who do NOT moor a boat at the Club. The annual fee for Social Members is **\$200 a year plus a one-time payment of \$250 for the Club Insurance Fee**. Social members do not have voting privileges in the Club but have full use of the Club facilities and access to all membership social events.
